- **Executive LLM**





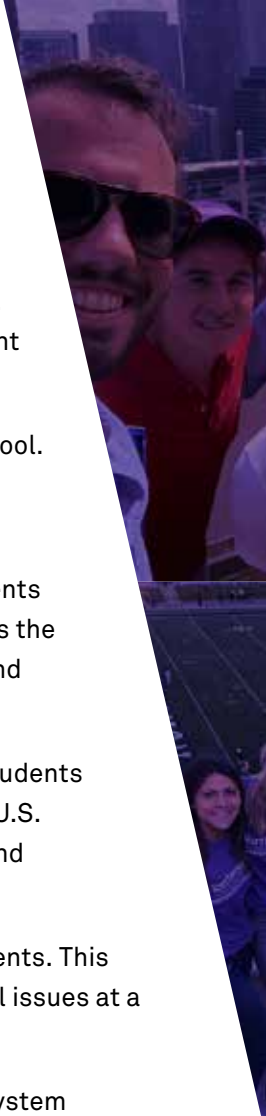

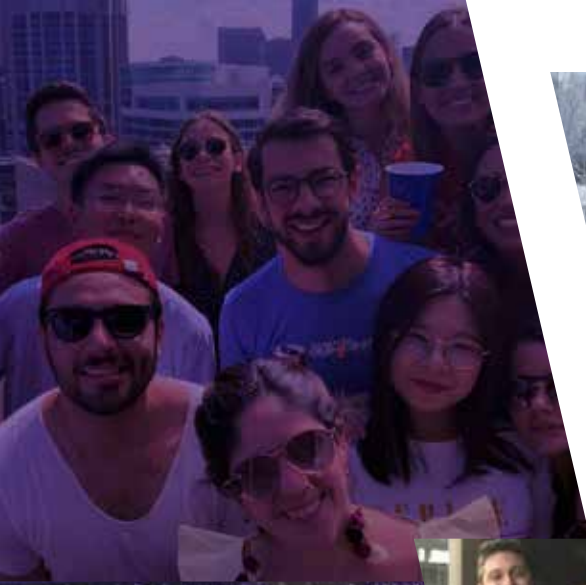
International Student Life on Campus

The International Programs Office ensures that international students and their families have an exciting and successful experience at Northwestern Law, both academically and personally. The following activities and events highlight the international student experience at Northwestern Law:

- **Global Village** celebrates the culture and diversity of the Law School. Students from all degree programs proudly share food, cultural customs, and performances from their homeland.
- **The LLM Committee** plans academic, professional, and social events of interest to current LLM students. The committee also advances the interests of the LLM students amongst the larger student body and collaborates with student organizations.
- **Lunch Lectures** are a series of lectures by faculty members for students in the LLM Class. Recent topics include the U.S. jury system, the U.S. asylum system, and dispute resolution relating to the Olympics and Olympic sports.
- **Global Conversations** is a semi-annual event open to all law students. This event provides students the opportunity to discuss cross-cultural issues at a higher level in a fun and relaxed setting.
- **Legal Field Trips** allow LLM students to experience the US legal system firsthand by visiting courts, law firms, government agencies, and corporations.
- **The Student Bar Association** invites LLM students to participate in its various committees. Additionally, an LLM representative is elected to the SBA board each fall. The SBA is highly committed to serving LLM students during their time at Northwestern.

Northwestern Law has more than 40 Student Organizations, all of which are open to international LLM students. Participating in student organizations is an excellent way for LLM students to gain knowledge, develop interests, and make friends.





International Student Support

At Northwestern, LLM students receive holistic support and participate and engage in interactive programming through the ACE Program, which stands for:

- Academic
- Curricular
- Career
- Cultural
- English
- Excellence

Through the ACE Program, LLM students participate in co-curricular and extra-curricular sessions to help them succeed academically and learn professional skills and cultural competencies that will benefit them throughout their legal careers.



GENERAL LLM PROGRAM

Program Structure and Curriculum

The General LLM Program at Northwestern is very flexible, allowing students to design a program of study that meets both their academic and career goals.

During their time in residence, students enroll in two mandatory courses – Common Law Reasoning, which focuses on the fundamental research, analysis, and drafting skills expected of U.S.-trained lawyers, and a course in American legal studies. With very few exceptions, LLM students are fully integrated with JD students in the classroom.

Students must complete at least 20 law credit hours to earn the LLM degree and are provided with a broad array of curricular choices. These include practical courses designed to build lawyering skills in areas such as negotiation, contract drafting, litigation and mediation. There are also many unique offerings in a variety of subject areas, such as law and business, civil litigation, law and technology, and alternative dispute resolution. Students may also have the opportunity to take courses through the Kellogg School of Management.

LLM graduates may qualify to sit for certain state bar exams if they meet specific entry requirements and complete the requisite coursework. The list includes New York and California, two of the most widely used among global companies.

Career Services

The LLM program has a dedicated career advisor who counsels LLM students and provides career guidance. The Career Strategy Center provides training and workshops on all aspects of a job search in the US, including cover letter and resume writing, networking, and interview preparation. Students may also participate in two virtual job fairs, where many larger American and international employers interview students for positions in the United States and abroad.

TAX LLM DEGREE PROGRAM

The Tax Program at Northwestern Pritzker School of Law is a recognized leader in the field. Our comprehensive curriculum, outstanding faculty and collaborative community provides students with a solid understanding of the complexities of tax law and the specialized skills needed to practice at all levels. With an average of 40 full-time students in the Tax Program each year, Northwestern offers a close-knit and collaborative learning environment in which students are able to develop close relationships with each other and with the faculty. International students typically comprise 15-20% of the Tax LLM Class each year.



Program Structure and Curriculum

Students in Northwestern's Tax Program must take eight required courses: two semesters of coursework in the following areas:

- Taxation of Property Transactions
- Corporate Taxation
- Partnership Taxation
- International Taxation

Beyond the required courses, students may choose from a wide array of elective courses to complete the degree requirements.

Tax LLM students have the option to earn a certificate in one of four substantive areas of taxation by earning 10 credits in one of the following areas of tax:

- Corporate Tax
- International Tax
- Tax Controversy
- Wealth Transfer and Legacy Planning



Career Services

The Tax Program has a career advisor devoted exclusively to students in the Tax Program. In addition to individual counseling appointments, the advisor provides tax-specific seminars, panels and workshops on such topics as tax careers, networking, interviewing and business etiquette. Northwestern also organizes and participates in the Tax Attorney Recruiting Event (TARE) job fair, which is held virtually during the spring semester.

INTERNATIONAL HUMAN RIGHTS LLM PROGRAM

The International Human Rights LLM Program (IHR) is designed for students who wish to undertake an in-depth study of international human rights law and international criminal law and their implementation by international courts and organizations and in domestic legal systems.

Because of the smaller class size, students in the IHR LLM program benefit from a close working relationship with the professors, all of whom have hands-on legal practice and academic experience in the field. Students also have access to programs in the Center for International Human Rights, which gives students the rare opportunity to combine classroom studies with immersive, hands-on, real-world advocacy on behalf of marginalized communities and individuals. With faculty supervision, CIHR students engage in advocacy before national and international tribunals and human rights bodies; their work may involve travel to countries such as Malawi, Ethiopia, Cambodia or Colombia to meet with victims and witnesses and work with NGO partners, or to Geneva, to participate in advocacy before UN human rights mechanisms.



Program Structure and Curriculum

The International Human Rights LLM curriculum consists of four required courses and an array of electives. Required courses, which fulfill 9 of the 20 credits required for the degree, are:

- International Human Rights Law
- International Criminal Law
- Common Law Reasoning
- International Human Rights Colloquium

Electives, which may vary from year to year, include the IHR clinic as well as courses on refugees and asylum; health and human rights; human trafficking; international environmental law; business and human rights; women, gender and human rights; public corruption; and graduate research/thesis.

EXECUTIVE LLM PROGRAMS

Northwestern Law offers three Executive LLM Programs tailored for legal and business professionals in Europe, East Asia, and the Middle East. These programs are specifically designed for individuals who cannot or prefer not to pursue a full-time Master of Laws (LLM) degree in the United States. The programs are made possible through strategic partnerships with renowned institutions: IE Law School in Madrid, Spain; KAIST Moon Soul Graduate School of Future Strategy in Seoul, South Korea; and Tel Aviv University, The Buchmann Faculty of Law in Tel Aviv, Israel.

In the Executive LLM Programs, students complete 20 credit hours of coursework through a blend of classes taken on the partner school campus, the Northwestern campus, and online modules. Expert faculty from both campuses impart knowledge, offering students the opportunity to learn from leading experts in countries across the globe. The class schedules are thoughtfully planned, enabling students to continue their professional careers while pursuing their LLM degree. ADMISSIONS

The application filing period for the LLM, and IHR LLM Programs is August 1 – January 15. The filing period for the Tax Program is September 1 – June 1.

Applicants to all programs must have a first degree in law and/or be eligible to sit for the bar exam in their home country. Applicants should also have a high level of English proficiency.

Interested candidates must apply through LSAC. A QR code that links to the LSAC application portal can be found on the last page of the brochure. A completed application consists of the following:

- Application for admission
- Personal statement
- Resume or Curriculum Vitae written in English
- The Law School LLM Credential Assembly Service (CAS) consisting of:
 - » *Post-Secondary Transcript(s) translated into English*
 - » *TOEFL or IELTS score report*
 - » *A minimum of one letter of recommendation*
- Non-refundable application fee of \$75 for all programs, except the IHR LLM

Applicants may also conduct an optional online video interview. Interviews are strongly encouraged, as they provide the Admissions Committee with additional information about your communication skills, maturity, academic focus and career goals.

FINANCIAL AID

The law school awards scholarships to admitted LLM applicants on a rolling basis after January 15. All applicants who have been admitted to the LLM and Tax LLM programs are automatically under consideration for a scholarship award; no additional form or application is required. Applicants admitted to the LLM in International Human Rights Program will receive a scholarship application with their letter of admission.

Scholarships for all programs typically only cover a portion of tuition costs. Therefore, applicants are encouraged to investigate other sources of support, including employers and government agencies, scholarship funds, and family and personal funds.
